## Waiver and Release of Liability – Feline

**THIS AGREEMENT is entered into by and between Beloved Animal Care and the named party (“Owner”):**

1. By enrolling the above named and described pet(s) in the attached intake form, I represent that I am the legal owner of the named pet(s) and I assume all risks, dangers, and responsibility for injuries to the named pet(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner’s pet(s) while Owner’s pet(s) is/are attending Beloved Animal Care.
2. Boarding extremely old, chronically ill, or otherwise debilitated pets requires extra care, which our caring and trained staff is happy to provide. However, special-needs pets, kittens and senior pets naturally have a higher risk of injury, stress-related illness, or exacerbation of any preexisting condition. As such, by boarding your special-needs, kitten, or senior cat with us you are waiving any claim for injury or illness experienced by your pet while in our care and that is not directly caused by the negligence or lack of care on the part of our staff.
3. Owner understands and agrees that during normal cat play, Owner’s cat may sustain injuries if two cats from the same household are boarded together. Beloved Animal Care will not board differing household cats in the same enclosure, and reserves the right to separate cats if needed based on behavior.
4. Owner further understands and agrees that neither Beloved Animal Care nor any of its employees, staff or volunteers, will be liable for any illness, injury, death, and/or escape of Owner’s pet(s) provided that reasonable care and precautions are followed, and Owner hereby releases all of them of any liability of any kind whatsoever arising from or as a result of Owner’s pet(s) attending or participating at Beloved Animal Care.
5. Owner further understands and agrees that any behavioral or physical health problems that develop with the Owner’s pet(s) while with Beloved

Animal Care will be handled and treated as deemed best by the employees, staff, and volunteers of Beloved Animal Care, in their sole discretion, and Owner expressly agrees to assume full financial responsibility for all expenses arising or relating thereto. This includes aggressive or destructive behavior.

6. Owner further understands and agrees that Owner's pet(s) are healthy. Owner(s) agrees that all cats attending Beloved Animal Care will have current vaccinations. Minimum vaccinations include, rabies, and feline distemper, when on-site.

7. Owner further understands and agrees that it is the Owner's responsibility to leave an adequate supply of food and medications for Owner's pet(s) during the entire time Owner's pet(s) is cared for by Beloved Animal Care. Should the food/medication supply need replacement, I authorize Beloved Animal Care to purchase replacement and Owner will reimburse Beloved Animal Care for cost plus a \$25.00 replacement fee (per occurrence).

8. Owner further understands and agrees that Owner's cat will have access to a safe and clean enclosed area with a litter box, food/water, bed, and scratching post. Owner agrees to assume full liability if Owner's animal escapes.

9. Owner further understands and agrees that if Owner's pet(s) is/are not picked up by the agreed pick-up time, then Owner hereby expressly authorizes Beloved Animal Care to take whatever action is deemed necessary for the continuing care of Owner's pet(s) and Owner agrees and promises to pay to Beloved Pet Care all costs of continuing such care upon demand by Beloved Animal Care. Further, Owner understands that if Owner does not pick up Owner's pet(s) as scheduled, Beloved Animal Care shall be authorized to proceed according to the local municipal code governing abandonment of animals.

10. Owner agrees to make sure any cat(s) are UTD with flea/tick prevention prior to boarding. Should a pet be observed to have fleas while attending on-site services, Capstar (given for treatment of fleas and ticks, not prevention) will be applied and charged to the owner at a minimum rate of \$20.00. To keep all our animals happy and healthy, Beloved Animal Care reserves the right to discontinue service to any pet(s) who exhibit signs of flea/tick/worm infestation.

11. Beloved Animal Care reserves the right to refuse admittance to any pet(s) or to dismiss any pet(s) that does not meet the health, temperament, or other

Beloved Pet Care standards. The determination shall be made at the sole discretion of Beloved Pet Care.

**Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.**
