Waiver and Release of Liability – Farm General

THIS AGREEMENT is entered into by and between Beloved Animal Care and the named party (“Owner”):

1. By enrolling the above named and described animal(s) in the attached intake form, I represent that I am the legal owner of the named animal(s) and I assume all risks, dangers, and responsibility for injuries to the named animal(s). Owner understands and agrees that Owner is solely responsible for any harm to Owner’s animal(s) while Owner’s animal(s) is/are being cared for by Beloved Animal Care.
2. Owner authorizes Beloved Animal Care to obtain any emergency veterinary care that may be necessary during the time spent with any animal(s). Owner accepts responsibility for any charges related to this emergency care. Owner also authorizes Beloved Animal Care to utilize an alternative veterinarian in the event my primary veterinarian is unavailable. Beloved Animal Care will make every effort to contact the owner/client prior to obtaining any emergency care for pet(s).
3. Owner must disclose to Beloved Animal Care all other persons having access to the home and property during the duration of care. Beloved Animal Care accepts no responsibility for security of the premises - Other than to shut gates, pens, and cages as instructed by Owner.
4. Beloved Animal Care is not responsible for lost/stolen property, or animals.
5. Owner agrees to reimburse Beloved Animal Care for any additional fees for providing emergency care, as well as

any expense incurred for unexpected visits, transportation, housing, food, or supplies.

6. Beloved Animal Care agrees to provide the services stated in this agreement in a reliable, caring, and trustworthy manner. In consideration of these services and as an express condition thereof, the owner expressly waives and relinquishes all claims against Beloved Animal Care, volunteers or staff, except those arising from a proven negligence of the farm sitter.
7. Beloved Animal Care will not be liable for the injury, disappearance, death, or fines of any animal with unsupervised access to the outdoors on Owner property. This includes injury to or from livestock due to fences, weather events, barns, sheds, or other faulty livestock enclosures/environmental factors.
8. Beloved Animal Care reserves the right to terminate this contract at its sole discretion; likewise, owner may terminate this contract. A minimum of 24 hours' notice is required cancelled visits. Visits cancelled past the 24-hour mark are subject to 50% payment of planned services. Currently Beloved Animal Care will take the following forms of payment: Cash, Check or Venmo (@BelovedAnimalCare).
9. Owner understands that if care cannot be completed due to aggressive animal behavior or environmental factors, Beloved Animal Care will not be held responsible.
10. It is expressly understood that Beloved Animal Care shall not be held responsible for any damage to client's property, or that of others, caused by client's animals during the period in which they are in care.
11. Owner attests to the fact that all licenses and vaccinations required by the State of VT have been administered to serviced animals.
12. Owner authorizes Beloved Animal Care to enter the listed premises during specified contract dates without additional signed contracts or written authorization to perform farm

sitting services discussed in consultation meeting and in this contract.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
